Hall of Fame Eligibility: A nominee is eligible upon retiring from active coaching for two consecutive state tournaments. Nominees should have completed a minimum of ten years in interscholastic wrestling coaching in the state of Washington. Any ACTIVE Washington State Coach may be eligible for nomination if they have coached for more than 20 years.

Nomination Procedure: Anyone can nominate a retired coach for the Hall of Fame, however, if the nominator is not a current wrestling coach in the state of Washington or a member of the WSWCA Hall of Fame they must secure an active coach as a sponsor. Deadline for submitting nominations will be April 1 of each year.
